I will be present for the three hour visit and we will all have a happy time as a family with Mum. That is her wish. We did it last February in Melbourne and you testified under oath at vota at feb 25th hearing that you were comfortable during the 2 1/2 hour visit. Your dad commented as you were leaving that it was a very nice visit and you agreed. So it will be this time. We can meet In Marina del Ray at Whiskey Reds or at Jerry's Deli in Woodland Hills, or some other restaurant if you prefer. Mum was very happy when I told her she would be seeing you, your Dad and Matilda on Saturday. Our visit will be exactly as it should be- happy family time together.

The only sham is you and your dad trying to override the professional assessments and rulings of 13 professionals including LA County Sheriff's Lost Hills Deputy and Detective, all of whom determined that Mum wants to be with me and my family here in LA.
